6. In case of his/her willingness to discontinue in the said assignment, he/she must intimate the undersigned through proper channel 15 (fifteen) days before tendering his/her resignation as House Staff.
7. The authority can terminate his/her House Staff ship issuing notice of 15 (fifteen) days in advance and is not liable to explain or show reason thereof.
8. On completion of above tenure of House Staff ship, the final certificate will be issued by the Head of this Institution.
