- No stipend will be paid to him/her by the authority for Non Stipendiary Post.
- No accommodation can be provided to him/her.
- This is a full time assignment. He/she must not engage himself/herself in private practice or job elsewhere during his/her tenure of House Staff ship.
- He/she will have to perform all jobs/duties including emergency/night duties as and when required by the authority.
- He/she must not participate in any strike or movement causing disruption of normal hospital services.
- In case of his/her willingness to discontinue in the said assignment, he/she must intimate the undersigned through proper channel 15 (fifteen) days before tendering his/her resignation as House Staff.
