Commencement of academic session for students admitted to
MBBS course in IPGME&R through NEET-UG 2026

The following points are to be noted

1. Academic session will commence from **29.09.2026** in online mode. On this day Welcome Address will be provided by Director, Dean of Student Affairs, and other college functionaries and students will be apprised about various rules and regulations.
2. The online session will be from 11:00 AM to 1:00 PM. Link will be notified through website Notice Board on 28.09.2026. Students are to join in time and through 1 link only.
3. Between 30.09.2026 and 02.10.2026 few sessions of the Foundation Program will be conducted in online mode. Agenda with timings will be notified in due course.
4. Students will report physically on **05.10.2026**. By this time the bulk of the admission process is likely to be over.
5. On **05.10.2026** students will assemble in Lecture Theater 6 on the top floor of UCM Building at 10:30 AM. Guardians are not allowed inside the Lecture Theater.
6. They must be in decent formal attire. There is no college uniform as such.
7. **Roll Numbers will be notified and attendance will be taken.**
8. The inaugural session will last till approximately 1:00 PM. Day scholars can disperse thereafter.
9. **Antiragging declaration** will be collected from all students on 05.10.2026. Note that such declaration has separate forms for student and legal guardian. All students and guardians must go through the antiragging regulations of the National Medical Commission - **National Medical Commission (Prevention and Prohibition of Ragging in Medical Colleges and Institutions) Regulations, 2021**. 10. From 2 PM onwards those students who are applying for hostels will report to designated locations for allocation of hostel seats. Every attempt will be made to allocate the rooms on 05.10.2026 only and provide access. If this is not possible then access will be a few days later on notified date.
11. Subject classes will begin in earnest from 06.10.2026.

Notice for prospective hostel residents among MBBS batch 2026-31

- **The college can provide a limited number of hostel seats (approximately 85-90 gents and 35-40 ladies) for first year MBBS students.**
- Hostel fees are Rs. 12/- (Rupees twelve) only per month for lodging. For food, the students have to make their own arrangements with hostel canteens or elsewhere and college does not collect any charge for this.
- Basic furniture, including cot, will be provided. Mattresses, towels, bedsheets, pillows, buckets, toiletries, etc. will have to be procured by the students themselves.
- First year students will be accommodated in an area separate from hostels of senior MBBS students. This may be dormitory style accommodation.
- **Those desiring to reside in hostel have to submit the Hostel Application form along with scanned copies of their AADHAAR card and, for state quota candidates, their domicile certificates as well.** Applications of male students who reside within a 50 km radius and female students who reside within a 40 km radius of the college (by shortest route) will not be considered. **Hence these students need not apply for hostel now.** If any student has any special medical need for residing in hostel, this may be mentioned and will be considered. Applications will be screened and decision of Hostel Committee regarding eligibility will be final.
- Students who wish to apply for a hostel seat must submit duly filled in Hostel Application Form on the day of admission. **Earlier to this, these students, both boys and girls, will have to submit scanned copies of the filled-up form (scan both sides) along with the two supporting documents (as a single pdf file) online** to the following address: <hostelsuperboys@gmail.com> (for male students) and <ipgmer.girlshostel@gmail.com> (for female students) latest by 30.09.2026. **Applications without supporting documents will NOT be considered.**
- Allocation will be strictly on distance basis and medical considerations if applicable. Obviously, if the number of applicants is more than the number of seats, all applicants cannot be allotted seats. Decision of the Hostel Committee will be final in this regard. Those left out will go into a waiting list which will generally be valid for 3 months. No recommendation / solicitation for allocation of hostel seats is acceptable.
- The actual seat which is allocated will be determined through lottery process to be conducted by Hostel Committee members on the first day of physical appearance.
- All those allotted hostel seats MUST abide by hostel rules and regulations that are mentioned on the reverse side of Hostel Application Form. Hostel superintendents are available to address legitimate concerns of boarders. However, unruly behavior will not be tolerated and may lead to cancellation of hostel seat and expulsion from hostel with intimation to Disciplinary Committee for further disciplinary action.
- If a student is allotted a hostel seat but is found absent from this seat for more than 1 month or is found to occupy the seat only occasionally, the allotment will be cancelled and seat will be transferred to a waitlisted student. Same will be done if a student voluntarily surrenders seat.

Terms and Conditions for Hostel Accommodation

IPGME&R accommodates a large section of its MBBS students in hostels. We want that the hostel stay should be smooth and enjoyable for all boarders – existing and new. Therefore, **no student will stay in the hostel without official allotment** and certain **DO's and DON'T's must be followed**. These are listed below and the applicant and his / her guardian must individually agree to all these terms and conditions. If you indicate that one or more items are not to your liking, your application will be **REJECTED**.

1	It is expected that all boarders follow accepted norms of decent behavior. I will do the same. Antiragging regulations in force on the campus are applicable to all hostel premises and I will abide by the same.	☐	☐
2	Hostel security staff has the mandate to regulate entry / exit at all hours and to check identity. I will cooperate with security staff on duty and produce official identity card, when required, during entry or exit.	☐	☐
