- The bidder must enclose a copy of the License to Manufacture for Sale or Distribution of Medical Device/ The Registration Certificate to Sale or
  Distribute or offer for sale or deliver Medical Devices issued by the Competent Authority in accordance with the Medical Device Rules, 2017.
