- Tender/Quotation must contain two separate sealed envelopes for Technical Bid and Financial Bid respectively. The Financial Bid shall be opened only if the tenderer satisfies technical Qualification.
- · Rate should not rate exceed by the rate notified by the NPPA & MRP.
- The bidder must enclose a copy of the License to Manufacture for Sale or Distribution of Medical Device/ The Registration
 Certificate to Sale or Distribute or offer for sale or deliver Medical Devices issued by the Competent Authority in accordance with
 the Medical Device Rules, 2017.
- The Purchasing Committee has every right to accept/ reject any quotation without assigning any reason thereof.
- No other charges except the GST will be acceptable.
- Goods must be delivered within 7 (seven) days from the date of supply / work order.
- The quotation should be valid for 365 days from the date of opening of quotation or till the procurement amount when reaches up
 to the maximum limit (Rs. 1 lac), whichever is earlier.
- If the L1 bidder found not able to comply the order within the stipulated time mentioned above, then the order will be
 automatically treated as cancelled. The undersigned will have the right to place the same before the L2 bidder without any
 communication to the L1 bidder.
- If any dispute OR reaction after using of the item arises, the selected bidder will have to replace the same without charging any
